We are currently looking at the possibility of enhancing the facility with purpose built covering which would enable all year round netball. More information will be available on this as it comes to hand.

Player forums have been held and information from these forums has helped us shape the competition for the coming years and as always, the board appreciates the feedback of our members.

I thank the netball community for their ongoing efforts and look forward to receiving positive reports about this competition for many years to come.

Indoor Facility

We have been working with the government on the outcome of the \$5 Million Dollar Grant towards a 4 court Indoor Facility at the Silverdome.

Our aim is to ensure that whatever works we do we can eventually have Junior and Senior competitions together at one location. It was this in mind as the Silverdome proved cost prohibitive, and \$5M was not going to build a 4 court facility, that we have made the decision to upgrade Hoblers Bridge with court covers, court and facility upgrades. There is a load of work to be completed in the background and we aim to begin construction work around this post 2023 season. Draft concepts will be available during our winter season.

In the background we are also utilising this grant to develop a business case study, work with government and councils to discuss a suitable location for our long term vision of a much larger community facility where netball is the major tenant. Our aim is to ensure that by the next Federal Election we are best placed to secure major funding.

Operation Manager

In 2022, the Operations team had a big mission, which was to turn our finances around without losing memberships and adding to our membership fees. Whilst this wasn't our only objective, you will see from financials that we have achieved this to a degree. It is a long term plan to be financially viable for future years. We have offered more competitions in season 2022 for our members, which have grown to 1600 players, along with coaches, officials and volunteers. This is a massive growth from 2021 and can be attributed to the NTNA offering more competitions.

In February 2022 we offered the Twilight Carnival, which didn't have a sponsor. We had a huge uptake of junior participants with several clubs using it as part of their grading process. Mixed and Masters teams travelled from the North West and Meander regions to compete on a warm afternoon. It was a great success and we are looking to grow this carnival in 2023, playing the Mixed and Masters at the Silverdome.

We did have plans to have Australia's Biggest Morning tea for the community to come to our facility for a cup of tea or coffee and a biscuit.

All donations were to go to the Cancer Council, however due to a significant amount of people contracting Covid-19, we did not go ahead. We will have this planned for 2023.

GRANT FUNDING

The NTNA were successful in acquiring \$20,000 from the Round 7 Communities Grant from Bridget Archer. This money has been allocated to resurfacing Centre Court 1 which was last resurfaced in 2005. It is well overdue. We thank Bridget Archer for the support of the NTNA.

This year we introduced shortened games into the Midweek grading roster, with the aim of teams playing each other on the night they had nominated to play. These games were not awarded points or players votes. Competition and clubs could also nominate what night their teams were to play, rather than be graded over the three nights.



From player feedback, this concept was well received and we felt the competitions across the three nights was competitive. We once again had Grand Final week with both our midweek and junior competitions finishing in the same week.

It makes for an exciting week with many supporters out and about.

Most grand finals were decided within 2-3 goals, with the most exciting being our Division 1 game between Amazonz and Gee Tees.

This was the first time Amazonz have had a team in Division 1 and it has been 15 years since Gee Tees won a Division 1 Grand Final. Gee Tees won by two goals after coming over the top of Amazonz in the last quarter.

For the pinnacle of our competition, it was great to see so many witness the Division 1 Grand Final and we hope this now is where our juniors want to strive for.


Our 17&Under Division 1 Grand Final was just as exciting with Amazonz pipping Generation by 4 goals at the final siren. The highlight also of both these games were the umpiring prowess of Rachael Stebbings officiating in these high level games.

It was an early start for our Junior Grand Final day with the introduction of the Presidents and Life Member Grand Final breakfast, kindly catered for by Banjos Bakery, Prospect. It was well attended by both Life Members and Club Presidents and it will be back in 2023. An overview of our season was presented at the Grand Final breakfast and the many old photos we had brought down to an appropriate level was well received. Jacinta Simeoni – Chair of the Indoor Facilities Committee also presented what we have been working on to be successful in getting an indoor facility. This, as you all know takes time and is slow going, however Jacinta continues to work tirelessly for this ultimate reward. We thank Jacinta for all the hard work she has been putting in campaigning local councillors and continuing talks she is having with State Government bodies.

Numbers have increased in 2022 for both our competitions with the Midweek roster having 67 teams registered and the Junior roster having 88 teams. Of these 88 teams, 13 were Net Set Go teams which gives the NTNA confidence going forward of our participation growth increasing.

Net Set Go Clinics commenced in October with most clubs running some form of clinic. This has been well received and there are a huge number of younger participants in these clinics. Well done to the club volunteers and older junior players running these.

We have tried for a few vears to get a Women's and Mixed Social roster up and going over the winter period. The only night an indoor court facility was available was a Sunday night, and this was not favourable for our social members, only having three teams enter. In June 2022, the YMCA in Kings Meadows unfortunately closed, which meant an opportunity for us to pick up social roster teams. With negotiation with both Netball Tasmania and the City of Launceston, we were able to secure the two three quarter courts at the old YMCA and take over the social rosters. This has been lucrative for the NTNA with the first roster being offered of ten weeks on a Tuesday (Women's Social) and Wednesday (Mixed Social) nights.



We have 12 teams competing in the Junior Statewide Representative Carnivals in 2022, with two teams in each age group. All our teams have been developing their skills of Netball being led by our coaches who are putting their time into coaching our junior players. With the STNA Monica McDevitt Carnival being held outside our netball season in November 2022, this does drag the season out. With the courts at the Tasmanian Netball Centre currently being unavailable due to flooding, all coaches have been trying to source other venues to train at which has been increasingly difficult at this time of year. We hope the players and coaches have enjoyed their time in our Athlete Development program.

We are looking to make some changes to the team structures in 2023, which is very exciting.

October 2022 we were scheduled to hold the 6 week after school Primary roster. We use this roster to be able to introduce umpiring to our junior members in a non-competitive environment where they can hone their skills with an umpire mentor present. We were all ready for this, until the weather gods had other ideas and our courts were flooded. The decision was made to cancel this roster as NTNA were not sure how long the courts would be out of action for

In the middle of our Midweek and Junior competitions, on a Thursday night we held Umpire Education sessions which were run by Rachael Stebbings, our very own National 'AA" badge umpire. There were 6 sessions which were well attended and these sessions covered a number of topics. We would like to keep these going in 2023 for the development of our umpires.

The Operations team have been doing a review of our policies after the winter competitions have been completed and are continually making improvements for the Review Committee to review before sending out to clubs. This is a massive job and is quite laborious. We hope clubs will take the time to read the changes so they can make an informed view before accepting or declining the changes.

Our policies are always evolving and we are trying to keep them current with Netball Australia member policies as well.

After the winter midweek and junior competitions had been completed the Operations team held a Season Planning forum with Club Presidents and Secretaries giving them an overview of ideas for 2023 as well as a review of the 2022 competitions. We thank everyone for taking the time to support this and we hope with some changes, this will make 2023 more exciting for you all.

In August 2022 a Midweek
Player forum was conducted
by Leigh Oswin, Community,
Sport & Rec where reviews
of our current competition
was discussed. This was for
players from all clubs who
do not sit on a club
committee. The forum was
well represented by most
clubs and lots of ideas came
out of it, some of which we
hope to implement in 2022.

At the end of our winter competitions, the NTNA love to get our members together to celebrate the year that was with our Annual Awards Night.

This year it was held the first Friday in September at the Silverdome in their main entrance. This was a great setting and we thank them for giving up their time to run the drinks station. We had a great turnout and we thank the Silverdome for the donation of the room, Cadootje for the gifts to our award recipients, Banjo's Bakery, Prospect for the food.

A special thank you to Blair Smith for the power point presentation and Angela Cresswell, Vice Chair of the Board for presenting the awards. This all contributed to a fantastic night.

In 2022, we had the pleasure of Katherine and her team at Laser Clinics Australia (Launceston) sponsoring the Northern Tasmanian Netball Association with our umpire development and our courtside package. It was wonderful to have her support and we hope we have this in 2023.

This year our junior competitions and carnivals had the bonus of Urban Coffee being in attendance. We thank them once again for their ongoing support of the Northern Tasmanian Netball Association and we look forward to working Jason and Trish once again in 2023.

Each year we outsource the operation of the canteen at the Tasmanian Netball Centre. This year, as in 2021, Food2U won the contract and we were thrilled to have them here every Saturday during the junior roster and on carnival days. We thank them also for their support.

The Operations team would also like to thank our regular Match Officials - Mel Hardinge, Claire Russell, Regina Blair and also our First Aid officers – Terry Murray, Nelson Overton and Mike Jessup for their work and efficiency in keeping games on time, managing spectators, officials and players and looking after the injured.

Friday 14th October 2022, we were hit by another flood, which had all our courts underwater. It did not get into the building, although the water was lapping the top step to the verandah area. Although this has put an end to NTNA using the courts at this stage until they are cleaned and sanitised, we can count ourselves very lucky it did not enter the building. The water did get to the same level as 2016, although this year it cleared away quite quickly.

We thank the City of Launceston for their efforts so far in the gradual clean up of the Tasmanian Netball Centre and we are looking forward to welcoming back our members to be able to use them again. It would be remiss of me not mention our Administration Officer, Blair Smith. The amount of hours she puts in to ensure our fixturing is uploaded online through the new software platform, PlayHQ and also the amount of time she was onto Support to clean up any errors we noticed in the program. She was able to stay on top of her work, have votes and qualifying quarters out in a timely manner as well as managing the registrations of our players and their queries. I cannot thank her enough for her professionalism and her commitment to the NTNA.

I would also like to thank the NTNA Board of Management for their support over the past twelve months. It has been a pleasure to work with you all.



Junior Competition

Our junior games commenced in March in 2022, with the first 5 rounds as grading rounds within the roster. This year's season went for 15 rounds with an additional three rounds of finals, the weather was very kind to us as we were only washed out for 1 round early in the roster.

This year we had 88 teams in our roster, resulting in approximately 40 games each Saturday, 6 games being our NetSetGo roster.

Finance

Andy Stuart

I have the pleasure of presenting the Financial Report of NTNA for the year ended 30 September 2022.

Statement of Income & Expenditure

Following the long period of COVID and the tumultuous effect upon our operations we have achieved a very satisfactory result due to the diligence and effort of our Operations Manager, Tracy Jones, and her operational team.

Whilst we have reported a minor loss for 2022, it is noted that it represents a significant improvement on operations from 2021. We still had a carry-over item from Netball Tasmania of fee collection, which will not exist in the years ahead now that they have fully implemented the online registration process.

Grant funding was interrupted by COVID once again but is being managed.

With the professional services of our administration staff, we are seeing better business opportunities being presented to the organisation which result in positive returns. The quick proposal to take-up the YMCA social roster opportunity is such an example.

This also represented Tracy negotiating successfully with Launceston City Council and Netball Tasmania for subsidised hire costs whilst we assessed the viability of this opportunity on our bottom line. Better office reporting with the transition to Xero also resulted in timeliness of reports and cost effectiveness.

KEY AREAS IN THE INCOME & EXPENDITURE

Income received from operating sources including affiliation fees, facility hire, and kiosk. Total income for the year was \$376,489, seeing an increase from the previous year.

Operating expenses totalled \$379,924 for the year. This has decreased from the previous year.

STATEMENT OF ASSETS & LIABILITIES

As at 30 September 2022, the net asset position was \$254,696. The Association remains in a position to continue trading into the future.

We maintain cash investments of \$277,016. Courtesy of ongoing efforts by the Board and Operations we have a \$5 Million grant for facilities development courtesy of strong election work on our behalf. This is being worked through to ensure the best outcomes for our local facilities can be achieved. It is not reported or represented in our financials in any way however.

Net assets continue to decrease each year due to operating losses. Despite the previous trend we are confident

that a positive profit should be attained in 2022-2023 based upon the efforts of Tracy Jones and her team.

SUMMARY

The Association has no borrowings, strong liquidity and remains in a sound financial position.

Due to the strength of operations that we have maintained, and the forecast we are hoping for next year, we have chosen not to recommend an increase in fees and charges. We hope this assists all players and families when they are faced with choices for their sporting opportunities. We will monitor this closely, as you would expect.

In closing, I extend my thanks to Tracy and Blair, plus all Directors, for an exceptional year. With operations now completely run by staff we rely upon their accuracy and commitment. Both Tracy and Blair have put in long hours and shown great commitment to our Association. We have had a terrific year courtesy of their efforts and I look forward to a successful year ahead.

Notes to the Financial Statements

For the Year Ended 30 September 2022

1 Summary of Significant Accounting Policies

(a) Basis of Preparation

These financial statements are a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (TAS) 1964. The committee has determined that the not-for-profit Association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(b) Income Tax

The Association is exempt from income tax under Division 50 of the Income Tax Assessment Act

(c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

(d) Property, Plant and Equipment

Property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all property, plant and equipment is depreciated over the useful lives of the assets to the Association commencing from the time the asset is held ready for use.

(e) Employee benefits

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than twelve months after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Cashflows are discounted using market yields on national government bonds with terms to maturity that match the expected timing of cashflows. Changes in the measurement of the liability are recognised in profit or loss.

Employee benefits are presented as current liabilities in the balance sheet if the Association does not have an unconditional right to defer settlement of the liability for at least 12 months after the reporting date regardless of the classification of the liability for measurement purposes under AASB 119.
